Investment Details

Spherion offers an affordable start-up model that can be scaled to fit your budget. *Estimated Initial Start-up Investment

	ESTIMATED COST	DESCRIPTION
Initial Franchise Fee	\$35,000	Fee to operate under the Spherion Franchise Program. For veterans, minority owners or those with five or more years of industry experience, there is a 25 percent discount, bringing the fee down to \$26,250.
Computer System	\$3,650 to \$5,750	This includes hardware and third-party software costs.
Real Estate	\$1,000 to \$3,200	This fee represents the cost of the monthly lease. Approximately 1,000 square feet will be needed to operate your business. The cost of leasing will vary depending upon location. You do not need to purchase real estate for your business.
Leasehold Improvements, Furniture & Fixtures	\$7,500 to \$15,500	This includes any build-out expenses; furniture bought or leased; and required signage.
Equipment	\$4,650 to \$10,500	You will need to purchase and/or lease equipment to operate your business including, but not limited to: telephone(s), copy machine, fax, calculator and similar office equipment.
Opening Advertising	\$1,050 to \$5,150	Before opening your business, you may place office opening print ads or radio ads. Actual cost will depend on the type of advertising you choose. In addition, Spherion will provide (at no cost to you) at least three direct mailings to prospects along with a supply of miscellaneous promotional materials.
Training Expenses	\$1,050 to \$5,150	Initial training expenses incurred include transportation, lodging, food and compensation for you and your staff. Cost will depend on the distance traveled to the training location and the type of accommodations you choose.

Start-up Supplies	\$510 to \$1,050	This includes general office supplies required to operate. Spherion will provide at no cost to you, an initial supply of forms, manuals and printed materials.
Insurance	\$2,100 to \$7,850	This amount represents pre-opening expenses for insurance as described in our Franchise Agreement.
Utility Deposits	\$160 to \$1,100	This cost represents deposits for utilities. Amounts will vary depending upon the location of your business and the practices of the utility company.
Professional Fees	\$1,050 to \$5,200	It is recommended that you employ an attorney, accountant and other consultants as needed.
Business Licenses	\$160 to \$1,100	In certain states, you must obtain a license to provide employment services. Fees vary from state to state.
Hardware Installation	\$720 to \$1,100	Generally through a Spherion preferred vendor, this covers the cost of installing equipment and hardware.
Additional Funds	\$51,500 to \$82,500	This is working capital to support ongoing expenses such as advertising fees and office payroll, to the extent that \$51,500 to \$82,500 of these costs are not covered by sales revenue. We estimate the amount stated will be sufficient to cover ongoing expenses for the first 12 months you are in business. However, you may need additional funds during or after this initial phase.
